With respect to the overall experiences in the College 84% of the students are reported as Excellent, and 16% of them are reported as Very good.



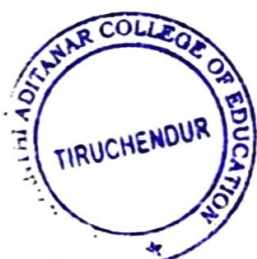
